Sensitive skin is particularly vulnerable to environmental factors such as the sun, the heat, dry wind, as well as to the presence of chemicals contained in hygiene products, and some specific fibres (e.g. Wool & some synthetic fibres).

Some people simply do not feel comfortable while using clothing made of fibres that feel rough when in contact with their skin.

Skintoskin offers highly comfortable and smooth clothing, free from chemicals or allergens, that help maintaining the balance of the skin's flora. Sensitive skin is protected and becomes less vulnerable to itching and discomfort brought up by the inflammation of the skin. The composition of our fabrics can help the treatment of Atopic Dermatitis (more commonly known as Eczema).

SKINTOSKIN® clothing is extremely well tolerated by all sensitive skin types. It protects and helps the skin find its natural balance.

Brown algae extracts protect the skin against itchiness. The algae are harvested in the icy waters of the North Sea and organically processed, free from added chemicals, guaranteeing high tolerance levels when it is in contact with the skin.

The **inclusion of silver nitrate** adds truly effective antiseptic properties, drastically reducing the growth of any potentially harmful bacteria on the skin, namely *Staphylococcus aureus* bacteria, which produce toxins and can be found in large quantities on the skin of people suffering from atopic conditions, causing and aggravating skin problems. Bacterial colonies are 100 times higher in normal skin and 1000 times higher in the inflamed skin of people who suffer from atopic conditions.

Do not use fabric softeners.

Wash before first use.

Use mild plant or mineral based detergents without fluorescent whitening agents.

Reference guide (composition) for detergents:

- 15% - 30% Zeolites
- 5% - 15% Oxy-whitening agent
- <5% Soap - anionic surfactants

This product contains silver; so it is not advisable for anyone who is allergic to silver.

Keep out of sunlight.
